



THE CODE ON WAGES, 2019 (HIGHLIGHTS)

Passed by the Lok Sabha on July 30, 2019, by the Rajya Sabha on August 2, 2019 and received Presidential assent on August 8, 2019.

DEFINITIONS |

 Inclusion of 'contractor' and 'contract labour' to make contractors liable to pay wages of contract labour




WAGES

- Common definition of the term 'wages' for uniform approach
- Change in base i.e Floor wages instead of minimum wages



PAYMENT OF WAGES

- No discrimination between men & women & transgender while getting wages.
- Mandatory to pay wages within 7 days from expiry of wage period, irrespective of size of establishment
- Special methodology for computation of wages, if required
- Amalgamation of applicable overtime rate RECORDS
- Consolidation of requirement of multiple registers



The Code on Wages, 2019

BONUS

- Change in eligibility and calculation criteria of bonus.
- Conviction for sexual harassment-addition in disqualification for payment of bonus



CLAIMS & OFFENCES

- Adjudication of claim within 3 years from the date of claim, as against varying time periods under the current law
- Allows for compounding of offences



 Concept of 'Inspector-cum-facilitator' instead of 'Inspector', having duties related to effective compliance.



ADVISORY BOARDS

- Central and State Advisory Board with representatives of both employers and employees.
- Fixation & revision of wage rate, increasing employment opportunities etc.


