<u>Meaning</u> - Company having only 1 member, <u>Nature</u> - Hybrid of Sole-Proprietor and Company, <u>Compliance requirements</u> - Minimal

• natural, resident, not a minor, member/ nominee in only one OPC

Nominee

 subscriber to nominate, prior written consent, becomes member in case of subscriber's death or his incapacity to contract

Change in nominee (INC-4)

• withdrawal of consent, death, incapacity of nominee

Financials

• balance sheet, P&L Account, Statement of changes in Equity

Board meeting

• min. 2 Board meeting during a calendar year with max. gap of 90 days between 2 meetings

Types of OPC

• limited by shares, guarantee or unlimited Company

Restriction

 incorporation or conversion into Section 8 Company, NBFC Activities

STRIKE-OFF

Annual filing











COMPULSORY CONVERSION

within 6 months if:

- Paid Up Share Capital Rs. 50 Lakhs and;
- Average annual turnover Rs. 2 crore
- Intimation to the RoC INC-5 within 60 days




