### Insolvency and Bankruptcy Code ('Code')- An overview

**IMPORTANT DEFINITIONS** 

non payment of whole or any part or instalment of the amount of debt which is due and payable

who owes debt to any person person person

owed, transferred or assigned debt w.r.t. Goods and services including employment, or Statutory dues

Owed, transferred or assigned debt with interest, disbursed against consideration for time value of money (Bonds, debentures, credit facilities, Lease, Receivables etc.)

A. Corporate Insolvency Resolution Process (CIRP)

Initiation

- Demand Notice (only FC)
- Application by OC, FC, or CD itself

**Resolution Plan** 

- •Formation of Committee of Creditors (CoC) & appointment of Resolution Professional (RP)
- Resolution Plan approved by CoC & NCLT

Liquidation /Revival

- Revival; OR
- Liquidation Formation of liquidation estate & distribution of assets


